ORDER

AND NOW, this 15th day of September, 2016, upon

consideration of Class Counsels' request for reimbursement of costs incurred since entry of this Court's December 21, 2015 Order issuing Final Approval of the Settlement between Plaintiffs and Defendants Robert J. Powell; Vision Holdings, LLC; and Powell Law Group, P.C. (collectively "Powell Defendants"), and any response thereto, IT IS HEREBY ORDERED that said motion is GRANTED. IT IS FURTHER ORDERED that:

- a. Class Counsel is hereby awarded costs in the amount of \$32,569.18 related to the Powell Defendants Settlement;
- b. The reimbursement of expenses shall be deposited by the Escrow Agent into an account maintained by Co-Lead Counsel within five (5) business


days after entry of this Order and then dispersed to the law firms in the amount each firm incurred and submitted;

c. The remaining funds from the uncashed original Powell Defendants Settlement checks shall be distributed in accordance with the plan of distribution to all Juveniles that cashed their original Powell Defendants Settlement check on October 26, 2016, in accordance with the Master Stipulation and Agreement of Settlement. The following deadlines shall govern the October 26, 2016, Powell Defendants Settlement checks:

- **The October 26, 2016**, Settlement checks shall not be honored after the date on which they become void, as printed on the face of the checks. Settlement checks shall be issued so that (a) they will be valid for a period of not less than ninety (90) days from the date of issue; and (b) none of them will be valid after **Monday, January 26, 2017**.
- **Monday, January 16, 2017**, shall be the last day that Class Counsel will accept updated addresses to re-send the October 26, 2016 Settlement check. It shall also be the last day that Class Counsel will cancel and re-issue Settlement checks.
- **Wednesday, January 19, 2017**, shall be the last day that Class Counsel will re-send the October 26, 2016 Settlement checks.

- **Monday, January 26, 2017**, shall be the last day that the October 26, 2016, Settlement checks will be honored. Funds associated with the October 26, 2016 Settlement checks shall no longer be available to the Settlement Members after this date.
